# STATED CLERK COMMUNICATIONS

The Stated Clerk recommends that the presbytery take the following actions:

- 1. Excuse from attendance persons who submitted excuses as recorded in the roll of this meeting.
- 2. Record this meeting as the annual corporate meeting for both the Presbytery of St. Augustine, Inc. and Montgomery Presbyterian Conference Center, Inc.
- Receive and admit to record that Larry Hadrava (RE Kirkwood) was commissioned to special pastoral service at the San Mateo Presbyterian Church on October 19, 2014. Earle Sickels (TE -Calvin) served as the moderator of the commissioning service.
- 4. Receive and record that the Trustees have (a) approved a contract to list for sale the property at 8084 Normandy Boulevard, Jacksonville, Florida, which has been vacated by the Nueva Esperanza Presbyterian Church (it is sharing space in mutual ministry with the Kirkwood

Presbyterian Church); (b) elected the Operating Board of the Montgomery Presbyterian Conference Center as contemplated by the presbytery action taken at the last stated meeting; and (c) approved the execution of the quit claim deed in connection with the dismissal of the Mandarin Presbyterian Church to ECO: A Covenant Order of Evangelical Presbyterians.

# **Korean Administrative Commission**

#### **PRESBYTERY COUNCIL**

Gabe Goodman, Moderator

The Presbytery Council recommends that the presbytery take the following actions:

1. Approve the following changes to the second and fourth paragraphs of Section 2.07 of the Manual of Operations of the Presbytery of St. Augustine (see underlined italics), which is entitled "Membership of the Presbytery." The purpose of these changes is to confirm that ruling elders commissioned to pastoral service are members of the presbytery with voice and vote during the terms of their commissions.

Membership of presbytery shall consist of all enrolled, ordained teaching elders, together with ruling elder commissioners elected by the session of each church of the presbytery. Sessions shall elect ruling elder commissioners according to congregational membership, according to the following table:

1-500 members1 commissioner501-1000 members2 commissioners1001-1500 members3 commissioners1501-2000 members4 commissioners2001-3000 members5 commissioners

3001 or more – one additional commissioner for each 1000 members (or major fraction thereof) above 3000 (G-3.0301).

Any ruling elder not commissioned by his/her church to serve as a commissioner to presbytery, while serving as the chairperson of a committee of presbytery, shall be enrolled as a member of presbytery during his/her tenure as chairperson. <u>Any ruling elder commissioned to pastoral service</u> <u>shall be enrolled as a member during the tenure of his/her commission</u>. Further, any ruling elder elected to an office in presbytery or serving as executive presbyter (including an interim or transitional executive presbyter) shall also be enrolled as a member of presbytery during the term of his/her office.

Certified Christian Educators who are ruling elders are entitled to the privileges of voice and vote at meetings of presbytery. (G-2.1103b).

At the winter stated meeting of each year, the stated clerk shall report to the presbytery the number of resident active teaching elder members of the presbytery, and the number of ruling elders in the following categories: ruling elder commissioners eligible to be elected from each session, ruling elders who are Certified Christian Educators or *commissioned to pastoral service*, and ruling elders who are moderators of committees or commissions of the presbytery. If the number of resident active teaching elders exceeds the sum of the ruling elders eligible, the stated clerk shall put forward a motion asking particular congregations to elect an additional elder commissioner in such numbers as will equalize the eligible ruling elder commissioners with resident active teaching elder members. The clerk shall create the list of congregations by rotating through the alphabetical list of congregations in the presbytery (G-3.0301).

2. Approve the following changes to the second paragraph of Section 4.16 of the Manual of Operations of the Presbytery of St. Augustine (see underlined italics and strike-outs). The purpose of these changes is to conform the terminology in the manual with the structure and terminology of the corporate documents adopted at the last stated meeting:

The Presbytery of St. Augustine exists in covenant relationship with Montgomery Presbyterian Conference Center, a wholly-owned camp, conference, and retreat facility located near Starke, Florida. The membership of the corporation, Montgomery Presbyterian Conference Center, Inc. is co-terminous with the membership of the Presbytery of St. Augustine, Inc., and the officers and trustees of one are the officers and trustees of the other. The presbytery supports the ministry of Montgomery Conference Center through contributions from its operating budget; the participation of its congregations and members in the programs and ministries of Montgomery Conference Center; through volunteer groups that help with improvements to the Conference Center site; through *participation in* the *Trustees'* election of the Montgomery Presbyterian Conference Center Board of Directors *Executive Operating Board*, upon nomination of that Board; and through the regular welcome and grant of privilege of voice to members of the Montgomery Conference Center program staff.

Montgomery Conference Center contributes to the ministry of the presbytery by offering a ministry of hospitality on behalf of the presbytery to congregations, members, ministers, and others; by conducting a high-quality, Christ-centered ministry of camping and retreat to the presbytery and, on behalf of the presbytery, to groups and organizations who seek the benefits of such ministry; by providing a place for groups and individuals to experience the goodness of God's creation; by offering opportunities for spiritual growth and education for pastors, leaders, and members of congregations; by supporting leadership development in the presbytery through ministry with youth and young adults; and by providing both a place and leadership for occasions of recreation and retreat.

The Executive Director of Montgomery Conference Center shall participate with the executive and administrative staff of the presbytery in staff planning and coordination.

3. Receive a written and oral report from the presbytery's Transition Steering Committee:

One year ago, in the winter 2014 stated meeting of our presbytery, the Transition Team was first charged with:

"Assisting the presbytery with defining its identity, mission and focus as the gathered saints of St. Augustine Presbytery, and making recommendations regarding the structure and funding necessary to bring about the new vision."

Over the last two and a half years, our presbytery has undergone a tremendous amount of transition:

\*We have split the Executive position into two positions: a part-time Clerk and full-time Interim Transitional Executive.

\*We have permanently lost presbytery staff (John, Alison, Dorothy), and a managed Resource Center.

\*We have lost all of the MPCC staff and hired new personnel.

\*Fractured relationships between churches and the presbytery have transpired.

At this juncture in our presbytery's re-formation, it is clear that we have moved well-beyond a transition phase. We have lived transition for 2 ½ years. The Transition Team believes that we have entered into a visioning phase, and, consequently, the presbytery must move beyond the confusing semantics of "transition," to more suitable language. We suggest the phrase "Discernment and

Design." We are now ready to discover and implement God's plan and purpose for the Presbytery of St. Augustine.

To this end, the Transition Team encourages the presbytery to engage fully in the "Holy Listening" sessions. These listening sessions will help initiate and deepen relationships among churches in our presbytery, as well as unearth identity issues, missional objectives, and a focus for our presbytery. Subsequent to the listening sessions, the Transition Team hopes to make recommendations regarding the structure and funding necessary to bring about the new vision.

The Steering Committee and Transition Team have reviewed the Presbytery Council's action to recommend that the presbytery empower the Transition Steering Committee to hire a consultant and to spend up to \$40,000 from unrestricted funds in connection with such action. One of the team's members will offer a motion to postpone consideration of this proposed action by the presbytery until the 2015 Spring Stated Meeting.

- 4. Empower the Transition Steering Committee to hire a consultant, if that is the action that the presbytery should take in the judgment of the Transition Steering Committee, and to spend up to \$40,000 from unrestricted funds in connection with such action.
- 5. Approve the Operating Budget (*Appendix F*). Note: subsequent to the Presbytery Council's approval of the recommended Operating Budget, the Administration and Finance Committee continued to work on revisions to the budget that were needed to reflect new/additional information. That budget (to be presented at the meeting) is contained in *Appendix I*.
- 6. Elect the following individuals to the Nominating and Representation Committee (TE means "teaching elder" and RE means "ruling elder") effective today.

2017 - Alfred Christopher (RE - Marion Oaks) (BM) 2017 - Joe Rigsby (TE - Woodlawn) (BM)

7. Elect Kristie Hall (RE - Kirkwood) (OF) to the Administrative Commission for the Korean Presbyterian Church effective today.

The Committee on Ministry recommends that the presbytery take the following actions:

1. Approve the retirement of Sam McCoy, a teaching elder member of this presbytery, and receive and record the following retirement resolution:

*Whereas* almighty God was pleased to knit together the bones of Samuel Lee McCoy in the womb, to form his flesh and breathe into him the breath of life; and

*Whereas* Sam entered this earthly life on October 2, 1942 in Morgantown, West Virginia simply because he wanted to be with his mother for the occasion; and

*Whereas* in those mountains known as "Almost Heaven," Sam came to experience the sovereignty and benevolence of God; and

*Whereas* God so loved Sam that he gave his only begotten son, so that Sam should not perish but inherit internal life, causing Sam to claim Jesus Christ as his Lord and Savior; and

Whereas God called Sam to the ministry at age fourteen; and

*Whereas* Sam earned his Bachelor of Arts from King College in Bristol, Tennessee in 1964 and his Master of Divinity from Union Theological Seminary in Virginia in 1968, and then was ordained to the ministry of Word and Sacrament by the Presbytery of Memphis on February 23, 1969; and

*Whereas* after leading senior high youth of Hanover Presbytery on two summer-long mission trips to Mexico and serving as Assistant Pastor at the Old Presbyterian Meeting House in Alexandria, Virginia, Sam pursued a CPE internship and residency in Tennessee and Maryland, and then established a CPE program at the Crownsville State Psychiatric Hospital in Maryland; and

*Whereas*, after ministering at the mental hospital for twenty-one years, Sam left to persecute the saints at Hermon Presbyterian Church in Potomac, Maryland, where he served fourteen years as Stated Supply; and

*Whereas*, simultaneously with the foregoing activities, Sam served one interim pastorate in Arkansas followed by nine more interim pastorates in the Greater Washington area (National Capital Presbytery); and

*Whereas* Sam's love for God's undersea creatures led him to be a volunteer scuba diver for fifteen years at the National Aquarium in Baltimore, where he fed the sharks, stingrays and fishes and officiated at one nationally televised underwater wedding; and

*Whereas*, after forty years of friendship, Sam finally proposed to Alice and came to live with his sweet bride in Jacksonville, Florida; and

*Whereas* Sam became a minister member of the Presbytery of St. Augustine and served as Parish Associate at Lakewood Presbyterian Church for three and a half years; and

*Whereas* the Lord God continues to use Sam as he proclaims God's Word and love to the congregation at First Presbyterian Church in Crescent City; and

Whereas Sam hopes to enjoy boating and walking the beaches in Florida with Alice;

*Now therefore be it resolved* that the Presbytery of St. Augustine does hereby grant to the Reverend Samuel Lee McCoy the status of Honorable Retirement, effective January 1, 2015, giving thanks to God for his faithful service to the Lord Jesus Christ; and

*Be it further resolved* that this resolution of thanksgiving and appreciation for Sam and his ministry be spread across the minutes of this meeting, dated February 7, 2015.

2. Approve the following memorial resolution celebrating the life of the Reverend SherylLynn Frazier, a teaching elder member of this presbytery, who died on November 11, 2014:

Whereas, SherylLynn Kimberleigh Frazier came into this world on June 20, 1968 on a military base in the Philippines to Guy Raymond Hinegardner and Eleanor Kay Robinson Hinegardner; and

Whereas, the Lord blessed her with a strong Christian home with parents who believed in following Christ in all areas of life, not just on Sunday mornings; and

Whereas, when SherylLynn was a little girl, just about three years old, she already had strong ideas about her life. She wrote in her journey of faith as a part of her ordination that when she was asked what she wanted to do when she grew up, she said, simply and emphatically - "I want to help people and be a mommy"; and

Whereas, the three-year old SherylLynn was likely to say, "I want to do it myself." She grew up an organized, independent and energetic child and teenager, qualities she maintained her whole life long; and

Whereas, SherylLynn made a public profession of faith at eight years old and was baptized that same year at Emmanuel Baptist Church at a Christian rock concert with thousands of people in attendance; and

Whereas, after becoming a member of the First United Presbyterian Church of Dale City, Virginia, SherylLynn first learned that women could be ordained as ministers of Word and Sacrament; and

Whereas, SherylLynn graduated from St. Andrews Presbyterian College, married Jeff Frazier, and moved to Stone Mountain, Georgia, where she later felt the call to go to seminary; and

Whereas the Eastminster Presbyterian Church in Stone Mountain affirmed her call, and she began her seminary education at Columbia Theological Seminary in 1991; and

Whereas, SherylLynn was blessed with three children, Alex, Hannah Grace and James, and found great joy in raising her family, being involved in their schools, and working both inside and outside the church before and after her graduation from seminary in 1995; and

Whereas, the Lord called SherylLynn to work as a teacher, a director of Christian education and youth, an assistant in the seminary library, an office manager/translator, and as a student intern in a church; and

Whereas, SherylLynn was called to be the Pastor of the Arlington Presbyterian Church (Jacksonville, Florida) and a member of the Presbytery of St. Augustine in 2010, where she was ordained as a teaching elder; and

Whereas, she served the Arlington congregation in obedience to Jesus Christ, proclaiming the good news, teaching the faith, visiting the sick and grieving, and caring for the people with Spirit-filled energy and passion; and

Whereas, one member described SherylLynn as "bursting with love" and always encouraging the members of the congregation to be ready to show their faith to all; and

Whereas, SherylLynn was a friend among her colleagues; loved her neighbors; shared encouragement, humor and the good news of the salvation through all means available, including sermons, correspondence, and social media; and worked for peace and reconciliation in the communities in which she was a part; and

Whereas, she was a dedicated member of the Committee on Preparation for Ministry, having an eye for detail in the process and an enthusiasm for shepherding inquirers and candidates for ministry under the presbytery's care; and

Whereas, SherylLynn was a speaker and leader on special occasions such as the First Presbyterian Church of Fernandina Beach's annual Women's Gathering at the "Carols, Candles, and Communion" service, where she led the group into a calming warm comfort in the peace of Christ as they took time to be centered in the rush of the holiday season; and

Whereas, SherylLynn enjoyed presbytery gatherings and meetings, attended many ordinations and installations of her colleagues, and, a short time before her death, attended a clergy retreat where colleagues were blessed by by her gifts of friendship, hospitality, humor, and self-sharing; and

Whereas one colleague recently wrote, after her time with SherylLynn at the retreat:

"Her family was her heart. Her church was her heart. Jesus Christ was her heart. The world was her heart. Vulnerable, hurting people were her heart"; and

Whereas, on the morning November 20, 2014, SherylLynn suffered a sudden heart event and died that morning at University of Florida Shands Hospital in Jacksonville, Florida at the age of 46; and

Whereas, on November 28, 2014, at the Arlington Presbyterian Church, a stunned and grieving congregation participated in a service of witness to the resurrection and gave thanks to God for the life of SherylLynn Frazier; and

Whereas, SherylLynn's minister colleagues processed and were seated behind her family at the service, showing their love and respect for SherylLynn; and

Whereas, SherylLynn is survived by her mother, Kay; her husband Jeffrie Frazier; their daughter Hannah Grace; two sons, Alex and James; a brother, Kenneth Hinegardner (Shannon); a sister, Kathryn Robison (Robert); other loving relatives and friends; and

Whereas, in her Statement of Belief written when she moved to the Presbytery of St. Augustine, SherylLynn stated with amazing conviction, "Death hath no sting for Jesus Christ is risen today! Alleluia! I believe in the Triune God of Surprises...The God of Surprises continues to astonish me in my daily struggle to follow Christ's call." SherylLynn was a disciple who embodied the grace, warmth and love of the Triune God of Surprises.

*Now be it resolved* that the Presbytery of St Augustine gives thanks for the life of SherylLynn Frazier, for her many years of service to Christ, for her love of others and building up of the community, and for her faithful witness, and it offers praise and prayer to God, on this 7th day of February, 2015.

3. Approve the following memorial resolution celebrating the life of Oscar Floyd Hooker, a teaching elder member of this presbytery, who died on December 16, 2014.

*Whereas* Oscar Floyd Hooker was born on 22 November 1922 to Jonathan Claude and Hattie Mary Grantham Hooker in Nashville, TN, the sixth of seven children and the youngest of five sons, being baptized into the Christian faith and membership of the Cumberland Presbyterian Church; and

*Whereas* Floyd was educated in the public schools of Nashville, graduating from Hume-Fogg High School in 1939; and

*Whereas* being faced with limited prospects for advancement, Floyd went to work as a carpenter's apprentice in the Tennessee Central Railroad shop, where his father had worked throughout his adult life, and where he left part of his middle finger as a result of careless use of the planer, thereby creating the occasion for a story to be told for decades to anyone unwise enough to ask; and

*Whereas* with the outbreak of World War II, Floyd's four older brothers entered the armed forces, and Floyd, though he sought to enlist, was denied enlistment because he worked in an essential industry; and

*Whereas* after his father's untimely death in 1944, Floyd received notice of impending induction into the military and was denied further deferment, even though he was the only remaining male in

his household, and he voluntarily entered the Army Air Corps, so that all five brothers in his family were simultaneously enlisted in military service; and

*Whereas* he served as a gunnery instructor aboard a bomber, and later as a chaplain's assistant in the occupation forces Germany, where he observed devastation wrought by the very weapons he was trained to use, even when wielded in the service of a so-called good, making of him a lifelong opponent of wars and weapons both great and small, a value he taught his children, and

Whereas upon his discharge from the military and using his government benefits, Floyd attended George Peabody College (now part of Vanderbilt University, explaining thereby his lifelong sympathies for losing teams and other underdogs) and graduated in 1950 with a degree in History; and

*Whereas* Floyd met Norma W. Porter, daughter of James Anderson and Ruth Louise Spann Porter, at a retreat sponsored by McKendree Methodist Church at a Tennessee resort formerly used as a gambling casino, thereby giving rise to the story he told people for the rest of his life that he met his wife at a casino run by the Methodist Church; and

*Whereas* he and Norma married on 27 August 1948 (or, to hear him tell it whenever asked in Norma's presence, 28 August), and to their union were born two children, Paul and Susanne, and, through them, two grandchildren and three great-grandchildren; and

*Whereas* Floyd discerned a call to ministry, perhaps under the influence of his eldest brother Malcolm, also a Presbyterian minister, and enrolled in Louisville Presbyterian Theological Seminary, graduating in 1953 with a Bachelors of Divinity; and

*Whereas* Floyd was ordained to the Ministry of the Word in the Presbyterian Church in the United States in 1953, and installed as pastor of the Bethsalem Presbyterian Church of Wartrace, TN, where he served until 1956; and

*Whereas* Floyd and Norma served pastorates at the Madison Presbyterian Church in Nashville (1956-1966), the Central Park-Ensley Presbyterian Church in Birmingham, AL (1966-1976) where he dealt with racial hatred and segregation in quiet but unyielding witness to justice and humanity, and the St Andrews Presbyterian Church in Charleston, SC (1976-1986); and

*Whereas* upon his retirement from active ministry, Floyd served joyfully in interim ministries in Nashville, TN; Edisto Island, SC; Darlington, SC; and Monck's Corner, SC; saying more than once that he discovered late in his ministry that his true calling was to interim pastorates; and

*Whereas* after his final interim he and Norma moved first to Memphis, then to Nashville, and finally to Jacksonville, where he joined the Presbytery of St. Augustine as an honorably retired member, and where he, along with his son Paul and grandson Chris, represented three generations of the same family in simultaneous membership of this presbytery; and

*Whereas* he and Norma became active participants at Riverside Presbyterian Church, where he taught in the Adult Sunday School program; and

*Whereas* late in life he and Norma moved to Westminster Woods at Julington Creek, where they joined a vibrant community of friends whom he came to love; and

*Whereas* on 16 December 2014, at the age of 92, Floyd died peacefully in the presence of his wife of sixty-six years and enfolded in the love of his family, his baptism now completed in his death in the Lord Jesus Christ, whom he served throughout his long life;

*Now be it resolved* that the Presbytery of St Augustine does this day remember in love its brother Oscar Floyd Hooker, does express its gratitude for his long and faithful ministry to many people in many places over many years, and does give thanks to God for his presence in our midst and in our hearts.

Blessed are they that die in the Lord, says the Spirit. They rest from their labors, and their works follow them.

- 4. Approve, with gratitude for its service, the dismissal of the Administrative Commission for the Mandarin Presbyterian Church.
- 5. Approve the transfer/dismissal of Jesse Alexander to ECO: A Covenant Order of Evangelical Presbyterians as of the date of this meeting.
- 6. Note: Lester L. Hale, who died on January 20, 2015, at the age of 101, will be honored with a memorial resolution at the Spring 2015 Stated Meeting.

# PRESBYTERY TRUSTEES

The Trustees recommend that the presbytery: (a) approve the sale of the property located at 8084 Normandy Blvd. in Jacksonville, Florida to Boos Development Group for the purchase price of \$800,000 and authorize the appropriate officers to execute the contract contained in *Appendix J* and the related closing documents; and (b) confirm the Trustees' authority to agree to a modification of the sale price or any other terms if the Trustees determine that the change is in the best interest of the presbytery. This is with the understanding that if the closing occurs, the presbytery will separately determine the use of the proceeds of the sale after receiving the recommendation of the Committee on Ministry in consultation with the Nueva Esperanza Presbyterian Church (the congregation that formerly occupied the property) and the Administration and Finance Committee.

1) The Montgomery Executive Operating Board met on Saturday, January 10, and decided to utilize the funds received for Montgomery in the Mandarin church dismissal for debt reduction, capital improvements and to establish a reserve account.

2) You have established a wonderful group of individuals to serve on our Board and we are excited about where Montgomery is heading. We have 14 individuals and 7 different committees working presently to make Montgomery Presbyterian Center even better.

#### **MUTUAL MISSION**

The Mutual Mission Committee submits the following written report in addition to an oral report to be made at the meeting and the financial materials contained in *Appendix H*.

A team of 14 individuals were part of our most recent Dental mission trip to Jamaica, held this January. Participants performed cleanings, extractions and helped make dentures during the week long trip. Funds were also sent to be used in constructing a home for a needy family identified by our partner denominations and the Jamaican Ministry of Health.

Many thanks to the congregations of Hodges Boulevard, Orange Park, Westminster, Lake City and Fort King for hosting focus groups in the past month. These sessions were designed to highlight the history and current efforts of Mutual Mission in Jamaica, and to solicit ideas for ways to reenergize support for this endeavor throughout the Presbytery. We are happy to bring a focus group to other churches as requested.

Team members are needed for the upcoming June Medical/Dental/Housing trip. The trip will run from June 14-20, and the cost is approximately \$1,000. Doctors, dentists, pharmacists, nurses, dental hygienists, and other medical personnel are needed, as well as those interested in building and repairing homes.

Applications are now available on the Presbytery website for the annual summer youth exchange. This trip is open to high school students, and costs \$900. Participants spend one week in Jamaica and one in the Jacksonville area doing mission work, and interacting with fellow team members made up of Jamaican youth and their leaders. This year's trip will run from July 8-21.

If you are interested in traveling to Jamaica to see what life is like, and to see our mission work in action, consider taking part in this year's Adult Exchange. We will be heading to Jamaica November 12-17, and you will have the chance to stay with a host family and learn about the local culture and cuisine. We will also take part in a volunteer activity, and learn more about our long partnership with several Jamaican denominations. Please consider going and seeing how your own church can become more involved in this important ministry. Cost for this trip is approximately \$600.

#### NORTHSIDE PRESBYTERIAN CHURCH REQUEST

The session of the Northside Presbyterian Church has requested (after the original docket was released) that the presbytery consider dissolving the congregation. A motion would be appropriate to empower the presbytery moderator (in consultation with the moderator of the Committee on Ministry) to appoint an administrative commission with the specific authority to take any or all of the following actions:

- 1. Consult with the members of the congregation regarding the proposed dissolution;
- 2. Convene the session and any other subsidiary entities in the congregation;
- 3. Dissolve the session and assume original jurisdiction (after hearing from the session);
- 4. Dissolve the congregation in consultation with the members and determine the effective date of dissolution;
- 5. Dissolve the agreement with the church's temporary pastor;
- 6. Receive members to a temporary presbytery roll or assign their membership to other congregations, in consultation with the members;

- 7. Receive the records of the session and take actions with respect to the church's personal property, business transactions, and real property (subject to the approval of the Presbytery Trustees as required);
- 8. Consult with and/or engage the services of presbytery committees or staff, and incur reasonable and necessary expenses such as for legal, financial, and insurance needs; and
- 9. Take such other actions as may be reasonable and necessary in connection with the proposed dissolution of the congregation.

# PROPOSED CONSTITUTIONAL AMENDMENTS BILLS AND OVERTURES COMMITTEE OF PRESBYTERY COUNCIL

Del Wallace, Chair

The Bills & Overtures Committee of the Presbytery Council makes the following recommendations based on its review and study of the proposed amendments to the *Book of Order of the Constitution of the Presbyterian Church (U.S.A.)* sent by the 221st General Assembly (2014) for vote by the presbyteries. Note: the following web link will provide additional background information:

As to Amendments 14-A through 14-F (Amending the current Book of Order)

#### 14-A. Renunciation of Jurisdiction On Amending G-2.0509

Shall G-2.0509 of the Form of Government be amended by adding the following new paragraph at the end of that section? [Text to be added or inserted is shown in italic.]

"Whenever a former teaching elder has renounced jurisdiction in the midst of a disciplinary proceeding as the accused, that former teaching elder shall not be permitted to perform any work, paid or volunteer, in any congregation or entity under the jurisdiction of the Presbyterian Church (U.S.A.).

The Committee recommends that the amendment be *disapproved*.

*Rationale:* Although the intention behind the proposed amendment is positive, the amendment as written is overly broad. It does not allow a local session the flexibility to make decisions about staff and volunteers that take into account the nature of the job position/volunteer work and the particular candidate's background.

#### 14-B.1. Final Assessment On Amending G-2.0607

Shall G-2.0607 be amended as follows? [Text to be deleted is shown with strike-through; text to be added or inserted is shown in italic.]

"A candidate may not enter into negotiation for his or her service as a teaching elder without approval of the presbytery *of care*. The presbytery shall record when it has certified a candidate ready for examination *by a presbytery* for ordination, pending a call. Evidence of readiness to begin ordered ministry as a teaching elder shall include:

"a. [Text in a.-c. remains unchanged.]

"d. satisfactory grades, together with the examination papers examination materials, together with evaluations that declare those materials satisfactory in the areas covered by any standard ordination examination approved by the General Assembly. Such examinations shall be prepared and administered by a body created by the presbyteries."

The Committee recommends that the amendment be approved.

*Rationale:* The amendment requires an evaluation that the examination materials are satisfactory but removes the specific reference to "seminary grades." The proposal also clarifies that the presbytery approving a candidate's readiness is the presbytery of care (not the calling presbytery).

#### 14-B.2. Accommodations On Amending G-2.0610

Shall G-2.0610 be amended as follows? [Text to be deleted is shown with strike-through; text to be added or inserted is shown in italic.]

#### "G-2.0610 Exceptions Accommodations to Particular Circumstances

"By a three-fourths vote, a presbytery When a presbytery concludes there are good and sufficient reasons for accommodations to the particular circumstances of an individual seeking ordination, it may, by a three-fourths vote, waive any of the requirements for ordination in G-2.06, except for those of G-2.0607d. If a presbytery judges that there are good and sufficient reasons why a candidate should not be required to satisfy the requirements of G-2.0607d, it shall approve by three-quarters vote some alternate means by which to ascertain the readiness of the candidate for ministry

in the areas covered by the standard ordination examinations. A full account of the reasons for exception *any waiver or alternate means to ascertain readiness* shall be included in the minutes of the presbytery and communicated to the presbytery to which an inquirer or candidate may be transferred."

The Committee recommends that the amendment be approved.

*Rationale:* The amendment makes it more clear when and how a presbytery may make accommodations for the particular circumstances of an individual seeking ordination.

#### 14-C. Child Protection Policy On Amending G-3.0106

Amend the fourth paragraph of G-3.0106 as follows: [Text to be added or inserted is shown in italic.]

"All councils shall adopt and implement a sexual misconduct policy and a child protection policy."

The Committee recommends that the amendment be approved.

*Rationale:* This amendment reflects the church's responsibility to provide a safe, thriving and nurturing environment for children.

#### 14-D. Minimum Composition of a Presbytery On Amending G-3.0301

Shall the second paragraph of G-3.0301 of the Form of Government be amended as follows? [Text to be added or inserted is shown in italic.]

"The minimum composition of a presbytery is ten duly constituted sessions and ten teaching elders, *unless an exception is approved by its synod and the General Assembly giving consideration to the responsibilities assigned to presbyteries in G-3-01 and G-3.03.*"

The Committee recommends that the amendment be approved.

*Rationale:* This amendment permits flexibility for configuring presbyteries in parts of our nation where there are few PCUSA congregations in a large geographic area. Exceptions will be reviewed and approved by the presbytery's synod and the General Assembly.

#### 14-E. Interreligious Stance On Amending G-5.010

Shall G-5.0102 be amended as follows: [Text to be deleted is shown with a strike-through; text to be added or inserted is shown as italic.]

"The Presbyterian Church (U.S.A.) at all levels seeks new will be open to and will seek opportunities for conversation and understanding respectful dialogue and mutual relationships with non-Christian entities and persons from other religious [entities] traditions. It does this in the faith that the church of Jesus Christ, by the power of the Holy Spirit, is a sign and means of God's intention for the wholeness of all humankind and all creation."

The Committee recommends that the amendment be approved.

*Rationale:* This is an updated statement of our denomination's local, regional, national and global ecumenism and its relationships with other faith traditions.

#### 14-F. Marriage On Amending W-4.9000

Amend W-4.9000 by striking the current text and replacing it with the following: [Text to be added or inserted is shown in italic.]

"Marriage is a gift God has given to all humankind for the well-being of the entire human family. Marriage involves a unique commitment between two people, traditionally a man and a woman, to love and support each other for the rest of their lives. The sacrificial love that unites the couple sustains them as faithful and responsible members of the church and the wider community.

"In civil law, marriage is a contract that recognizes the rights and obligations of the married couple in society. In the Reformed tradition, marriage is also a covenant in which God has an active part, and which the community of faith publicly witnesses and acknowledges.

"If they meet the requirements of the civil jurisdiction in which they intend to marry, a couple may request that a service of Christian marriage be conducted by a teaching elder in the Presbyterian Church (U.S.A.), who is authorized, though not required, to act as an agent of the civil jurisdiction in recording the marriage contract. A couple requesting a service of Christian marriage shall receive instruction from the teaching elder, who may agree to the couple's request only if, in the judgment of the teaching elder, the couple demonstrate sufficient understanding of the nature of the marriage covenant and commitment to living their lives together according to its values. In making this decision, the teaching elder may seek the counsel of the session, which has authority to permit or deny the use of church property for a marriage service. "The marriage service shall be conducted in a manner appropriate to this covenant and to the forms of Reformed worship, under the direction of the teaching elder and the supervision of the session (W-1.4004–.4006). In a service of marriage, the couple marry each other by exchanging mutual promises. The teaching elder witnesses the couple's promises and pronounces God's blessing upon their union. The community of faith pledges to support the couple in upholding their promises; prayers may be offered for the couple, for the communities that support them, and for all who seek to live in faithfulness.

"A service of worship recognizing a civil marriage and confirming it in the community of faith may be appropriate when requested by the couple. The service will be similar to the marriage service except that the statements made shall reflect the fact that the couple is already married to one another according to the laws of the civil jurisdiction."

"Nothing herein shall compel a teaching elder to perform nor compel a session to authorize the use of church property for a marriage service that the teaching elder or the session believes is contrary to the teaching elder's or the session's discernment of the Holy Spirit and their understanding of the Word of God."

In lieu of a recommendation, the Bills and Overtures Committee has invited the Stated Clerk to make a brief presentation on the history of the current provision and the proposed amendment. That will be followed by two presentations from members of the presbytery, one speaking in favor, and one opposed. Debate and discussion will follow these presentations.
