- The Council reviewed the results of the online poll taken of the participants at the Spring stated meeting of Presbytery, including a discussion of the comments made.
 - [At approximately 10:45, the Chair became ill and excused himself from the meeting. Jerie Lukefahr was then unanimously elected by the Council to serve as moderator for the remainder of the meeting. As an ex-officio member, she did not participate in any votes.]
- The Council heard a presentation from Monica Williams regarding the MPCC summer camp plans, including a report on measures being followed by the staff to address and minimize risks regarding possible introduction or spread of the COVID 19 virus.
- The Council approved the nominations of Jake Young (Class of 2022) to the Care and Reconciliation Team and Anne Reid Broos (Class of 2021) to the Church Vitality Team, respectively.

- The Council next took up for action a letter from the Session of Middleburg Presbyterian Church advising that the church intended to close permanently, effective June 27, 2021. After extensive discussion, the Council, upon motion properly made, seconded and passed, took the following actions:
 - (1) Joe Rigsby, as Area Relationship Coordinator, was designated to meet with Yvan Kelly (if possible) and any other appropriate members of the congregation to determine if any action short of closing the church might be appropriate; and.
 - (2) Depending upon the report of Joe Rigsby of the results of his meeting or meetings, should the request to initiate closure of the church not be withdrawn by the Middleburg session, the Moderator of the Presbytery is authorized, in consultation with the Stated Clerk, to call a special meeting of the Presbytery to elect an administrative commission for Middleburg Presbyterian Church with the authority to assume original jurisdiction (if appropriate) and to carry out the process of closing the church. Prior to such special meeting, the Moderator, the Trustees Chair, the Ministry and Mission Coordinator and the Stated Clerk shall identify persons to serve on such administrative commission so that they may be elected at the special meeting if the administrative commission is approved.
- The Council approved a motion to designate July 15, 2021 as the date by which applications for designated funds must be submitted for consideration as part of the designated funds disbursement process.
